

Reiki Session Permissions & Terms Overview

Reiki is a simple, gentle, energy technique that is used for stress reduction and relaxation.

I understand that Reiki practitioners do not diagnose conditions nor do they prescribe or perform medical treatment, prescribe substances, they do not interfere with the treatment of a licensed medical professional.

I understand that Reiki does not take the place of medical care. It is recommended that I see a qualified healthcare professional for any physical or psychological ailments I may have. I understand, however, that Reiki can complement any medical or psychological care I may be receiving.

I also understand that the body has the ability to heal itself and to do so, complete relaxation is often beneficial. I acknowledge that long term imbalances in the body sometimes require multiple sessions in order to facilitate the level of relaxation needed by the body to heal itself.

I have read, understood and I accept full responsibility for my decision to receive Reiki therapy and by continuing with the session I understand I am signifying my agreement in full.

I agree I will promptly communicate any discomfort experienced during the session to allow necessary adjustments.

I confirm that I have no health conditions that would prevent me from having Reiki Sessions.

I release my practitioner from any responsibility and liability for any circumstances that I may perceive as being associated with any or all healing sessions I receive including but not limited to any decisions, actions, or outcomes resulting from the session. Reiki is complementary and should not replace professional advice you and you alone are responsible for your actions and healing.

I, understand that all information shared with the Reiki practitioner during my Reiki sessions is considered confidential. This includes all records and notes pertaining to the sessions. The Reiki practitioner will not disclose any personal information or details about the sessions to any third party without my prior written consent, except as required by law (e.g., in cases of imminent risk of harm to myself or others, or as otherwise required by law).

I understand that there may be occasions when it is in my best interest for my Reiki practitioner to communicate with other healthcare providers or individuals about my sessions. On such occasions, I will be asked to sign a specific Release of Information form.

In going forward with your session you are declaring openly for your highest good, that you are open to receiving Reiki Healing and you give you full permission for Faye Casement to administer the Reiki therapy to you.

You can cancel for a full refund if done no later than 24 hours before the session. Cancellations within 24 hours or after the session are not permissible, however, remember Reiki knows no space or time therefore the session can go ahead without you.
